Format: **Round Robin Play (guarantee to play 3 matches)**
Four teams will be created from the pool of entries. An individual may play either singles or doubles but not both. Two individuals may enter as a doubles team. Each player or doubles team will be assigned a ranking within their team and then play a round robin against the players or doubles team that has the same ranking.

Example: The number one ranked player from Team A will play the number one ranked player from Teams B, C, and D. Every player is guaranteed to play 3 matches (one per day). All matches are two out of three to 21 points, with an 11 point tie breaker if necessary. The winner of a match earns 1 point for his or her team.

Prizes: **The team that earns the most points will be awarded prizes.**
