- Dates:** Hall of Fame play will start at 4 p.m. Friday, March 13.
- Entry fee:** \$60 per player (one event only); juniors and college students are \$30 (\$50 for non-participant). Entry fee must accompany entry. Fee includes souvenir, hospitality and Saturday luncheon at the Hall of Fame. All entrants who visit the Hall of Fame during tournament week (check hours of operation) receive a can of handballs.
- Deadline:** Entries must include fees and be received by Thursday, March 3. Seeding committee reserves the right to reclassify or deny any entry, as well as combine or cancel divisions.
