Sanctioning criteria:

- ◆ Return completed sanctioning agreement with tournament entry/info
- ◆ Enforce USHA Rules, (mandatory eye protection).
- ◆ Use official 21 Red Label & White Label handballs.
- ◆ Provide registration list and results to USHA after the tournament
- ◆ Upon proof of USHA membership, a \$5 rebate or a USHA headband or a can of handballs to each current member. (USHA headquarters can verify membership prior to the tournament).
- ◆ **Agree to post USHA membership information and offer to each player. Upon completion of the tournament, provide the registration list and results to the USHA**
